1. EXECUTIVE SUMMARY

1.1 INTRODUCTION

Mazbat College is a premier co-educational institution of higher education, which was established on 25th August, 1988. The college is situated in Mazbat, District Udalguri under Bodoland Territorial Region(BTR)in the state of Assam, India. The college is situated in a rural interstate border area of Assam and Arunachal Pradesh, where different ethnic communities like Tea Tribes, Bodos, Assamese, Nepali, Rabha, Bengali, Garo etc. live coherently in the midst of nature even though they have their own language, culture and religion. The college being a single stream of arts strives to impart quality value based higher education in this greater ethnic community dominated area. To fulfill the educational aspirations of the public for higher education the college was started with arts stream by few of the great visionaries, philanthropists and social workers of this locality. The college has been tirelessly striving to impart higher education at under graduate level for the all round development of students and helping communities of the vicinity to showcase their rich cultural, spiritual and social practices all are proud of. Being the sole higher educational institution in this vast area this college shoulders the responsibility of torch bearer of knowledge and skill for the people of the locality and beyond.

The college was permanently affiliated to Gauhati University initially till 2019 but since 2020 the college was affiliated to Bodoland University, BTR, Assam vide Govt. Notification no AHE, 156/2020/19 dated 02-07-2020 by maintaining status quo. The college runs as per the affiliating university's courses and programs with CBCS. The college offers the following core subjects - Assamese, Bodo, English, Economics, Education, History, Philosophy and Political Science. The College has been included under sections 2(f) on 8 September 2008 and 12(B) on 17th November, 2009 as per the UGC Act, 1956. There are four digital classrooms along with indoor stadium, Auditorium, Gymnasium facilities in the college campus.. As an institution of higher education the college strives to provide best of education to students coming from different socio-cultural and economic background to contribute valuable service to the society and nation.

- III. Well stocked central library over 10556 books including journals.Besides this all Departments have their own departmental Libraies to cater the needs of students.Moreover teachers and students can access Eresources through different platform like INFLIBNET,N-list,Soodhganga,SWAYAM etc.
- IV.IQAC strives to formulate and implement policies towards its goal to impart quality education through stakeholders evaluation with the support of Management.
- V. To explore inherent talent of the students different cells, committees and IQAC continiously engage for the development of personality of the students.
- VI. State of infrastructure, Wi-Fi enabled campus, safe drinking water, LCD Projector, Smart class room, Laboratory and playground as well as indoor stadium.

Institutional Weakness

- 1. The College is located in a rural and remote area of Assam.
- 2. At the infrastructure level the college is in need of more classrooms owing to the introduction of semester system and increased enrolment.
- 3. Income generation sources are limited.
- 4. Road communications to reach the college from feeding areas are very bad.
- 5. Irregular and poor internet service and frequent power cuts.
- 6. The college is yet to setup Management Information System. (MIS)
- 7. The college is in a flood prone area and is badly affected by it.
- 8. Limited numbers of sanctioned Faculty members.
- 9. The hostel has not adequate facilities like security arrangement, warden quarter, office etc.

Institutional Opportunity

- I. To enhance further academic standards of the college by focussing on potential of the students and the faculty members.
- II. By improving sports infrastructure as well as training, there is an opportunity of creating a better sporting culture.

- III. By introducing more certificate courses would increase the chances of employability of students.
- IV. By introducing locally relevant courses on skill development would enhance the better livelihood for students.
- V. There is an opportunity to start Science and Commerce stream.
- VI. There is an opportunity of establishing museum cum cultural complex to preserve and assimilate different culture, customery practices of diverse communities of the area.

Institutional Challenge

- I. Transportation issues and inconvenience caused on account of being situated in a rural area.
- II. Most of the students are from diverse socio-economic and cultural background.
- III. A large number of students need to help in farming as agriculture is major livelihood of their parents.
- IV. Language barrier and low communication skills of the students is another aspects that affect while communicating and assimilating with peers as well as teachers.
- V. To maintain the stride with dynamic requirements and changes in higher education.

1.3 CRITERIA WISE SUMMARY

Curricular Aspects

Mazbat College implemented the Choice Based Credit System (CBCS) in 2019 in all departments in accordance with the regulations of Gauhati University (G.U), Guwahati. The college utilizes a well-structured Outcome Based Education (OBE) process to ensure effective curriculum delivery and to produce socially committed, employable, innovative, and research-oriented students. In 2021 Mazbat College transferred from Gauhati University to Bodoland University (B.U.) of Assam following CBCS. The college is proactive in introducing new-generation programs and exposing students to various national education platforms. The Curriculum Delivery and Planning Process is managed by the IQAC, which holds a meeting at the start of each academic year to review the syllabi of each subject. The Annual Academic Plan, also known as the Academic Calendar of the College, is prepared by the Academic Committee annually based on the university's academic calendar and departmental academic plans. The plan is published in the college prospectus and displayed on the college website. The departmental academic plans are displayed on departmental notice boards. The college prospectus, designed by the Prospectus Committee, provides information on programs and courses, including program outcomes, program-specific outcomes, course outcomes, syllabi, and emphasizing the weightage of internal and external exams. The college website also provides E-Resources prepared by faculty members and a Question Bank containing model question papers and old university question papers of both the Universities. The College Timetable is available on the college website and is updated regularly. For new programs, HoDs direct teachers to prepare Program Outcomes and Course Outcomes, which are approved by the Departmental Advisory Committee. Faculty members also develop a Course Plan that aligns with the attainment of course outcomes.

College adheres to the academic calendar set by Gauhati University and Bodoland University both, including the conduct of Continuous Internal Evaluation (CIE). The college follows the university's evaluation norms, including the implementation of CBCS from the academic year 2019-20 under G.U. and from 2021 under B.U. Internal assessment (IA) for theory subjects consists of 20% of the total marks, and is based on sessional exams, assignments, and attendance. For non-CBCS courses, there are two-unit tests, each worth 20% marks, and the average of the two is counted. The college conducts one sessional exam per semester for convenience and the marks are proportionately converted to out of 10 marks. 20% of the IA marks are awarded based on class attendance, with a minimum of 75% required. The remaining 30% of IA marks are awarded based on performance in practical (For practical courses) or home assignments, seminars/group discussions, fieldwork, and co-curricular/extra-curricular activities (for non-practical courses). For non-CBCS students, academic projects are evaluated for 75 marks (60 marks for the project, 10 marks for the presentation, and 5 marks for a viva-voce examination). The viva-voce exam is conducted by a board of three members, including the project supervisor and an external from a different college. For CBCS students, a project worth 6 credits can be undertaken in lieu of a 6 credit DSE course in the 5th semester.

Teaching-learning and Evaluation

The college caters to students' higher educational aspirations coming from diverse socio-economic and educational backgrounds and the faculties are committed to provide value based quality education which is relevant and meaningful. The curriculum followed and designed so as to make it student centric, outcome based education to promote holistic development that can transform a learner to be a valued skilful resource individually that can make positive contribution to the society and nation. To meet the core objectives of education which is all inclusive and relevant to the present day context the college faculty adopts teaching strategy and methodologies which is suitable to meet the expectations and needs of the learner coming from comparatively poor academic background and abilities in the best possible way.

For the effective implementation of the programmes and courses the college faculties adopt own instructional design keeping in mind the level of learners academic background and cognitive ability for their smooth acquisition of knowledge and skill. The college as per University norms is under CBCS since 2019. To meet the desired outcome of the programmes and courses which is primarily focused on delivering the contents in the most effective manner the faculty adopts learner centric methodology for better understanding and knowledge acquisition. For that bilingual method is used by the faculty in the classroom transaction along with traditional talk and chalk method and ICT based tools including use of Projector, Smart Board, Smart LED Screen, WhatsApp Groups and digital library facility for enhanced learning experience.

For the experiential learning of the students, faculty adopts and implement own instructional design depending on course content which is conducive to learner's need and ability which includes home assignment, field visit, report writing etc.

For the effective student centric learning, faculty gives due importance to participative learning by way of group discussion, seminar and presentation on select topics where students of the concern department participate under the guidance of concern departmental faculty.

Research, Innovations and Extension

Mazbat College, Mazbat, Udalguri is one of the premier institution of higher education in Bodoland Territorial Region (BTR), Assam. The college was established in 1988. The College continues to strive to impart quality value based education which is socially and ethically relevant at the local, regional and global perspectives. The College is presently affiliated to Bodoland University and has an enrolment of more than 1100 students running eight UG Departments under CBCS excluding PG program in open and distance learning mode.

Being an institution of undergraduate course, Mazbat College has adopted different innovative measures to cater the needs of students coming from diverse socio-economic and linguistic background. College has also constituted a research and innovation cell to streamline all the innovative practices taken by the college with following objectives:

To inculcate the idea of entrepreneurship among all the students community.

To promote, monitor and nurture new ideas and innovation among faculties.

To conduct workshop / seminar / conferences on regular basis to encourage the students to become job creator rather than job seekers and for faculty members to be updated with recent research trends.

To arrange field / industry visit for the students for firsthand knowledge gathering and motivate them for entrepreneurialship.

Besides these, the IQAC has taken different proactive initiatives to reach out to the students, Alumni, stakeholders etc by adopting online and offline feedback survey mechanism and grievances redressesal mechanism. IQAC and different departments of the college have organised numbers of workshops on research methodology and other area of research interest. All the departments have their own WhatsApp Group for information alert and information sharing to remain updated with the recent trends and happenings in the academic and knowledge domain.

The college constantly endeavors to remain true to its vision and mission by not only by imparting best of value based quality education supplemented by development of skill set to its students for transforming self as a valued skilled human resource that can make positive contribute to society and nation building.

Infrastructure and Learning Resources

In 1988, Mazbat College started its humble journey in a room of Bapuji Bhawan at Mazbat Town. Later, it shifted to present location in its own plot of land where construction of new campus buildings started and today it has an adequate infrastructural facilities with enrolment of above 1000 students in U.G. courses, although there is a scope of further improvement with necessary addition of infrastructural development.

Mazbat College has the land measuring 10.4 acres with super built up area of 4211 square meters. The college has an infrastructure namely Administrative building, regular classrooms and 4 nos. of classrooms with ICT facility, Auditorium, Digital Library, Computer Laboratory etc are currently available in its campus. The departments are equipped with computer and printers.

The institution has a Multi Gym with basic gymnasium equipments and yoga facility and an Indoor Stadium with sufficient numbers of indoor and outdoor sports equipments for different games and sports.

There is a Solar Power plant in the college campus for necessary powers supply and generation. High power generator facility is also available which helped to run electric equipments uninterruptedly.

As sound body is necessary for sound mind students are always inspirited to join various cultural activities organized by the college like Annual College Week, Freshman Social, Farewell programmes, Debates Competition, Extempore Speech competition, Quiz, Saraswati Puja and by joining in Youth Festival organized by the affiliating University. Departments organize departmental freshman social and farewell and observed various important days and events as indicated in academic calendar of the institution. The students are motivated to take part in different local festivals and events under the guidance of faculty members.

The college has a well equipped digital central library with 10,569 numbers of text and reference books, around 4 nos. of print journals, and e-resources through N-List, 3 nos. of daily regional news papers available for the students and the faculty members for their perusal.

Student Support and Progression

The College has a well placed system and mechanism for students support and progression. As an only institution of higher education established in rural area majority of the students come from poor socio-economic background. These students mostly belongs to Scheduled Tribes (ST), Scheduled Caste(SC), Other Backward Class(OBC), More Other Backward Class(MOBC) and religious minorities. Most of these students come under the purview of Government's fee waiver; scheme and enrolled without any fees. In the College students of this category are also entitled to post-metric scholarship and other central Government Scholarship Scheme. Students of the college are also given free Hostel Accomodation within the campus. There are also different cells like academic committee, Career Guidance and Counselling cell, women cell, Anti-Ragging and Sexual Harassment Prevention Cell, Grievances Redressal Cell, Mentor Mentee etc. in the College to extend all possible support to students and monitor their progression as and wherever necessary mentally, physically and emotional apart from academically monitored by different respective departments. Meritorious students of the college coming out with flying colours in the University examination are also fete with certificate and cash incentives. To cater to the need and extention of support to the DAP students the college provides ramp facility along with walking support tools and wheel chair.

To monitor the academic progression of the college students the college has academic monitoring cell which displays at the entrace of the college on a billboard different academic and professional courses one can take up right after graduation. It also collects the data base of the passout students of the college and the further acdemic and professional advancement of them. The different departments of the college also maintains a seperate database of departmental students of each departments to higher academic and professional courses. The college

has prime objective of making all possible effort of letting students get access and ability to next higher level of education after their graduation from the institution.

Governance, Leadership and Management

The college governing body is the apex decision making body of the institution. It is headed by President as it's Chairman and Principal of the college as it's secretary. It also comprises other elected members and nominees. This body plans and executes the overall management of the institution. It is held twice in a year; however, its frequency depends on the urgency arising out from time to time. Under its purview come finance, budget, expenditures and audit on academic, administration and infrastructural development and expenses. The Principal as the head of the institution is responsible for the proper execution and implementation of all the resolution and proposals approved by the Governing Body. The head of the institution as a leader of the institution inspires and motivates both teachers and non-teaching staff including the students for working with the best of potential and possibilities for better outcome. To ensure quality in every possible aspects the institution has a functional IQAC headed by a coordinator to monitor qualitative standard and improvement in administration, infrastructure, technology, academic curriculum, extracurriculum and maintaining liaison with all the stake holders. For effective implementation of tenets of values and quality different functional cells are formed and performe different activities as required by respective cells. It ensures total involvement of all the stakeholder for the qualitative and quantitative development of the institution in particular and public in general.

Institutional preparedness for NEP

1. Multidisciplinary/interdisciplinary:	Mazbat college is presently running only with Arts stream. But the college has plan to expand more discipline to solve the problems of limited specialization and narrow area of study. More emphasis will be given in the field of vocational, skilled, environmental and technology. Students as well as the faculties will be given more autonomy so that they can engaged themselves in innovation of ideas of new thought for teaching and learning. Entire future plan and programs taken by the institution will be successful with the support of government, parent university and after setting up a high quality Multi-disciplinary university in(or close to) home district.

2. Academic bank of credits (ABC):	Mazbat college has the plan to register in ABC via NAD (National Academic Depository) to store the academic data of credits of the students. So being the owner of academic awards our institution is going to register under ABC via NAD. The college organised numbers of international webinars and FDP where numbers of Resource persons and participants joined from different countries. This relation will help the institution in foreign collaboration in near future.
3. Skill development:	Mazbat college has already skill oriented course under affiliating university in different subjects. The college has plan to introduce more skill enhancement courses with the permission of appropriate authority for the interest of the students which will help them for their self employment as well as make them fit for the job.
4. Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course):	To educate the students about the rich language and culture of the communities that they belongs to the college has been running certificate courses on different ethnic dance-forms and folk -songs like Bihu, Jhumur, Kherai, folk songs. The college has been running courses on Assamese and Bodo as MIL besides as Communication or Elective courses under CBCS. More courses on other ethnic local language is going to be introduced soon. There are plans to expand the courses on performing art through digital platform to reach out to all interested in such courses.
5. Focus on Outcome based education (OBE):	Mazbat College is running with limited resources. But the institution has the proper plan to meet the NEP by adding different interdisciplinary programs for the benefit of students. All the departments will also take initiative for introducing programs focusing on Outcome Based Education (OBE)
6. Distance education/online education:	Mazbat college has already the centres of Distance and open education under three prestigious universities of academic excellence. IDOL(Institute of Distance and Open Learning) is running under Gauhati University for both UG and PG courses in Atrs. Study centre of KKHSOU(Krishna Kanta Handiqui State Open University) Assam has been running since the year of 2012 with UG and PG courses. A large number of teachers from elementary level under Udalguri district have been trained through ODL mode. Tezpur University(Central) has also permitted to take admission in specific subjects

from the last academic session. Almost all the teachers are familiar with the recent development of educational technology .All these technologies have been used in online teaching and learning specially during covid-19 pandemic.

1.1 Curricular Planning and Implementation

1.1.1 The Institution ensures effective curriculum planning and delivery through a well-planned and documented process including Academic calendar and conduct of continuous internal Assessment

Response:

Mazbat College implemented the Choice Based Credit System (CBCS) in 2019 in all departments in accordance with the regulations of Gauhati University (G.U), Guwahati. The college utilizes a wellstructured Outcome Based Education (OBE) process to ensure effective curriculum delivery and to produce socially committed, employable, innovative, and research-oriented students. In 2021 Mazbat College transferred from Gauhati University to Bodoland University (B.U.) of Assam following CBCS. The college is proactive in introducing new-generation programs and exposing students to various national education platforms. The Curriculum Delivery and Planning Process is managed by the IQAC, which holds a meeting at the start of each academic year to review the syllabi of each subject. The Annual Academic Plan, also known as the Academic Calendar of the College, is prepared by the Academic Committee annually based on the university's academic calendar and departmental academic plans. The plan is published in the college prospectus and displayed on the college website. The departmental academic plans are displayed on departmental notice boards. The college prospectus, designed by the Prospectus Committee, provides information on programs and courses, including program outcomes, program-specific outcomes, course outcomes, syllabi, and emphasizing the weightage of internal and external exams. The college website also provides E-Resources prepared by faculty members and a Question Bank containing model question papers and old university question papers of both the Universities. The College Timetable is available on the college website and is updated regularly. For new programs, HoDs direct teachers to prepare Program Outcomes and Course Outcomes, which are approved by the Departmental Advisory Committee. Faculty members also develop a Course Plan that aligns with the attainment of course outcomes.

College adheres to the academic calendar set by Gauhati University and Bodoland University both, including the conduct of Continuous Internal Evaluation (CIE). The college follows the university's evaluation norms, including the implementation of CBCS from the academic year 2019-20 under G.U. and from 2021 under B.U. Internal assessment (IA) for theory subjects consists of 20% of the total marks, and is based on sessional exams, assignments, and attendance. For non-CBCS courses, there are two-unit tests, each worth 20% marks, and the average of the two is counted. The college conducts one sessional exam per semester for convenience and the marks are proportionately converted to out of 10 marks. 20% of the IA marks are awarded based on class attendance, with a minimum of 75% required. The remaining 30% of IA marks are awarded based on performance in practical (For practical courses) or home assignments, seminars/group discussions, fieldwork, and co-curricular/extra-curricular activities (for non-practical courses). For non-CBCS students, academic projects are evaluated for 75 marks (60 marks for the project, 10 marks for the presentation, and 5 marks for a viva-voce examination). The viva-voce exam is conducted by a board of three members, including the project supervisor and an external from a different college. For CBCS students, a project worth 6 credits can be undertaken in lieu of a 6 credit DSE course in the 5th semester.

The College has integrated crosscutting issues such as Professional Ethics, Gender, Human Values, Environment, and Sustainability into its curriculum. As an affiliated college of Gauhati University, the curriculum is designed to include these issues to a certain extent. In addition, the certificate courses also touch upon these subjects. The syllabus of various departments, such as Economics, English, History, Political Science, Education, and Assamese, covers gender sensitivity, environmental protection, and sustainability, and human values. For example, Economics includes topics related to gender sensitivity in the 5th and 6th semester, and environmental protection in the 5th and 6th semester. Environmental Studies is a compulsory course for all students in the 2nd semester that deals with environmental protection and sustainability. The college also places a strong emphasis on human values and students are taught various issues related to this topic in subjects like Economics, Education, English, History, Political Science, and Assamese. In addition, there is a certificate course on Study of Archaeological Facts, Music (Xur Xomoloy), Data Analysis. Topics such as work culture, analyzing data in real world situation, personal integrity, ethical behavior, equality, transparency, and hygiene in the workplace are covered in all subjects.

Professional Ethics: In the syllabus of Education, English and Political Science, included some chapter of professional ethics. The topics like Ethical Behaviour, work culture, knowledge of quality check, healthy environment in workplace, personnel integrity, equality to women worker, respect for elders are always taught to the students.

Gender Sensitivity: The syllabus of History, Economics, Political Science, English, Education has the contents related to gender sensitivity issues. History has in all semesters, Economics has this issues in 5th and 6th semesters, Political Science in all except 3rd semester, English has in 1st and 2nd semester and Education has in 5th and 6th semesters gender issues related contents.

Human Values: The institution always involved related to human behavior and human rights and the students are taught the issues and its solution in respect of this. Topics related to society, family, community, social control, functions of cultures, social relationship, social behavior are taught in all humanities subjects.

Environment and Sustainability: As per the syllabus of G.U. and B.U. both the college runs a compulsory paper for Environmental Studies in the 2nd semester for all students, which has the contents regarding Environment protection and sustainability. Moreover, all departments of this institution has taken activities like tree plantation, solid waste management, making paperless college campus, use of solar energy, pollution free soil, prohibition of plastic use for environmental protection.

Response:

The college caters to students' higher educational aspirations coming from diverged socio-economic and educational backgrounds and the faculties are committed to provide value based quality education which is relevant and meaningful. The curriculum followed and designed so as to make it student centric, outcome based education to promote holistic development that can transform a learner to be a valued skilful resource individually that can make positive contribution to the society and nation. To meet the core objectives of education which is all inclusive and relevant to the present day context the college faculty adopts teaching strategy and methodologies which is suitable to meet the expectations and needs of the learner coming from comparatively poor academic background and abilities in the best possible way.

For the effective implementation of the programmes and courses the college faculties adopt own instructional design keeping in mind the level of learners academic background and cognitive ability for their smooth acquisition of knowledge and skill. The college as per University norms is under CBCS since 2019. There are total eight departments in the college viz Assamese, Bodo, English, Economics, Education, History, Philosophy and Political Science offering Regular and Honours courses along with course on environmental studies, ability enhancement communication courses and skill enhancement courses in each semester.

To meet the desired outcome of the programmes and courses which is primarily focused on delivering the contents in the most effective manner the faculty adopts learner centric methodology for better understanding and knowledge acquisition. For that bilingual method is used by the faculty in the classroom transaction along with traditional talk and chalk method and ICT based tools including use of Projector, Smart Board, Smart LED Screen, WhatsApp Groups and digital library facility for enhanced learning

experience.

For the experiential learning of the students, faculty adopts and implement own instructional design depending on course content which is conducive to learner's need and ability which includes home assignment, field visit, report writing etc.

For the effective student centric learning, faculty gives due importance to participative learning by way of group discussion, seminar and presentation on select topics where students of the concern department participate under the guidance of concern departmental faculty.

In order to develop the skills of leadership, problem solving and critical thinking students gets an opportunity to get themselves involve in various curricular and extra-curricular activities viz debate, extempore speech, quiz, writing for wall magazine, college magazine, games and sports etc. organized by the departments and the college as per academic calendar. This ensures individual growth by taking collective responsibility and working in collaboration to meet a desired goal. To ensure that college chalkout both academic and non-academic activities in each session outside classroom environment where students are encouraged to participate and explore individual interest and talent.

2.5 Evaluation Process and Reforms

2.5.1 Mechanism of internal/ external assessment is transparent and the grievance redressal system is time- bound and efficient

Response:

The college has a well placed mechanism of assessment process to gauge the learning outcomes of the learners at the end of the completion of particular course which is conducted in most transparent manner and adopts procedures to enhance the quality of such assessment. The system of assessment as per University rule includes both internal and external examination. The marks weightage is 20% for internal and 80% for external examination to be awarded by both college and University respectively for each semester.

The internal assessment is conducted through a well structured mechanism as per the University guidelines. The academic committee after discussion informs the same to the HoD of each department. The internal assessment and evaluation are conducted departmentally at their own convenience following the parameters comprising class test, sudden test, home assignments, sessional test. Apart from that there are other ancillary internal assessment measures adopted like class attendance, project, field-trip report, seminar presentation, GD. The evaluation of these are done departmentally and recorded systematically semester-wise. The performance of the students are discussed in the classes, mistakes are pointed out to them. The results of internal assessment is declared on time and displayed on the notice board or in WhatsApp groups. Post-assessment necessary remedial classes conducted for weak learners to enhance their learning and clarify their doubts. All these internal assessment parameters forms a part of the assessment protocol to evaluate the learning outcomes of the students. The entire process of these internal assessments is monitored and supervised by the academic committee headed by the college vice-principal.

The final semester examination is held at the end of the semester as a part of external assessment as per

University schedule. The mechanism to assess the overall learning outcomes of a student depends on the examination protocol followed by the University which is strictly followed by the examination centre. For the smooth conduct of the semester end examination the college Examination committee appoints Principal as the officer in-charge and assistant officer in-charge for carrying out the overall duty and responsibilities of the examination. The examination is held in a most free and fair manner under the watchful eye of the invigilators appointed from among the teachers. The whole process of examination is supervised by external supervisory officer appointed by the University to detect any anomaly at any stage of the examination.

The college provides ample scope to the students to redress any grievances related to both internal and external examination related evaluation or marks. They can directly approach the HoD of the departments with their grievances if any and it is promptly sorted out departmentally through discussion among the faculty in a time bound and effective manner.

External examination related grievances are addressed through the potal available in the University website. It has its own time bound redressal mechanism to deal with any examinee related issues arising out of external examination which is at the purview of the University norms.

The concerned departments have outlined the broader programme outcomes and the course-wise specific outcomes. These outcomes give a concrete road map to the faculty and students covering the whole gamut of curriculum that drives the entire teaching-learning process and these are clearly stated and displayed in the institutional website for the information of all stakeholders.

The Programme Outcome is decided by the concern HoDs of the department in consultation with the members of the faculty. It comprises the entire curricula activities followed by the departments to enhance the level of learning of the students. The college authority and IQAC adopt measures for proper and timely implementation of stated POs and COs. It also encompasses other extra-curricular activities for the

The Course Outcome is based on the University syllabus which is course specific. The faculty of respective departments discuss and specifies the course-wise outcomes, timeline for completion of syllabus, progress of the learners. Accordingly, departmental faculty prepares the instructional design which is enabled by ICT tools and adopting student centric methodology suiting their prior learning, experience and abilities putting emphasis on the inclusive learning community to achieve their potential. To realise that effective teaching learning strategy is adopted making the students involved in participative and collaborative learning to enhance learning experience, knowledge to reach the desired goal as an individual with attitudes, skills and values after the completion of the course.

The evaluation of the attainment of POs and COs are conducted based on the performance of the learners in different curricular and extra-curricular activities. The performance of learners in different academic activities like internal or external examination, departmental seminar presentation, project report, field-trip report, class test etc. along with other extracurricular performances are evaluated. Moreover, communication skills, behavioural aspects and independent learning capacity of a student also gets due importance in the overall assessment. After evaluation wherever necessary proper individual support and corrective measures like tutorials, special classes, remedial classes are conducted for the slow and weak learners.



4.2 Library as a Learning Resource

4.2.1 Library is automated using Integrated Library Management System (ILMS), subscription to eresources, amount spent on purchase of books, journals and per day usage of library

Response:

The Central Library of Mazbat College has record from 1991 which was done manually and the record was kept in Accession Register. At present the Library contains 10569 text and reference books. There are some printed Journals, Magazines, Periodicals and E-Journals. The Central library is the member of National Library and Information Services Infrastructure for scholarly content (N-List). The teaching staff have been acquiring resources from the N-List.

There are two rooms of the Central Library. The main room is 50 feet long and 30 feet wide. The room is used for the purpose of keeping the books as well as for reading room for both students and teachers with the seating capacity of 40 and 8 respectively. The area of another room is 30 x 8 Square feet which is used for keeping the book shelf.

Officially, the Central Library was partially automated using software KOHA Version 3.22.09.000.KOHA is very useful Library Management System in providing various library service to users including circulation of library material, cataloging of new arrival resources etc.KOHA is integrated with RFID etc.At the very beginning data entry of six thousand books were done and after that the process of data entry is going on till date. In order to start circulation system the bar code printer and scanner was used.

The Library is integrated with RFID and it has been smoothly running from 9th February 2021. Acquisition of serial, maintaining issue records, sending reminders of missing issues will be undertaken for automation shortly. User's educational and training programs are arranged from time to time for the new students to introduce them with automatic process of the library. They are also introduced to online public access system. The OPAC is available to the users to identify the present status of resources in the library.

The library has been connected with internet connectivity for accessing E-resources of the library so that the users of the library can access resources at their own convenience. The library is fully automated with the Wi-Fi. The library is also under the surveillance of CCTV camera for proper maintenance and security.

The college library has also preserved copies of M.Phil and Ph.D Thesis of different faculty members for the benefit of library users for pursuance of higher study. Recently the step has been taken of Book Bank facility for the needy students specially those who comes from economically backward family. They can borrow required books after taking a valid Book Bank Card.

4.3 IT Infrastructure

Institution frequently updates its IT facilities and provides sufficient bandwidth for internet connection: At Mazbat College there are 43 computers (Desktop 38, Laptop 5) which are used for various purposes in the interest of the students. One main computer is used by the Principal for communicating all the official documents with higher authority as well as to his subordinate staff. The official staff uses two computers to perform their allotted task. There are four computers and other machinery tools for library automation. These are used for digitalization of learning resources and to enhance their knowledge accessibility through reading and to face the challenges of modern competitive world. The computers are used for providing various library services and keep records updated. The library was partially automated using KOHA Software Version 3.22.09.000. In the year 2018 data entry of more than six thousand books were done and after that the process of data entry is going on till date. From 2021 RFID has been running smoothly. The students have been getting present status of the library through OPAC. They can also use the Wi-Fi facility. In central library two CCTV cameras have been connected. There is a system of digital signature for students as well as teaching and non[1]teaching staff to keep record of the users. The College authority decided to introduce IT facilities from the academic year 2013-14. In 2013 a computer center was opened with three computers. At that time a Certificate in Computer Application (CCA) course wasintroduced. A total of total 99 students enrolled for the three months CCA course and after successful complication of the course they were given a certificate. At present twenty computers are connected in the computer center to conduct the computer classes smoothly among the students. These computers are connected with 10 mbps

internetspeed. The students use the computer to access necessary information and data. So far this computer center has trained students of the college in basic computing skills. Presently Mazbat College has tie- -up with MSME Govt. of India, Tool Room & Training Centre, Guwahati (TRTC) for Skill upgradation of the students. MSME has permitted the college to stat a course on DTP from academic session 2022-23 with an intake capacity of 50 students. The College authority has provided total eight desktops and five laptop to each department and faculty for using in the departmental task and classroom transaction. This helps in the better teaching learning experience of the students and faculty. The teaching staff has been using four digital classrooms for teaching learning process. Digital or virtual class is most effective class for students. The classrooms are equipped with smartboard, projectors and LED screens which helps the students in better understanding and innovative learning and confidents building. The teachers and students are greatly benefited by the use of ICT in the classrooms. It also ease the process of office work and administration of the college

Mazbat College has well defined policies and procedures of administrative setup. For Academic matters related to degree programmes, it operates as per guidance of the Bodoland University. Directorate of Higher Education is the Statutory Body of the college. It also follows the rules and regulations of the UGC. College receive grants from Government of Assam, UGC etc. At college level the Governing Body is the apex body and Principal is the Drawing and Disbursing Authority. There are different committees under the leadership of Principal for overall management of the college. IQAC and Principal Office have reciprocal relation in terms of quality management. Effective functioning of these committees is visible from policies, procedures like service books, appointment and promotion system, code of conduct etc.

Governing Body: The Governing Body is constituted as per the state government rules and provisions. It has 12 members in all. The President is Sri Dipak Mour Hon'ble MCLA of no 39 Pachnwi Sefang Constituency. The Principal of the college is the Secretary. Other members are representatives from different fields.

Administrative Set Up: The G.B. President and the Secretary form the nucleus of the college administration. The Principal is the executive head of the college and is the final authority in all financial matters. The Principal implements all the decisions resolved in GB in the capacity of Secretary and also serve as Drawing and Disbursing Officer of the college on behalf of the state government. The Principal has a dedicated team comprising the IQAC Coordinator, the departmental Heads and the members to assist him in the disbursing the entire administrative works.

The Functions of Various Bodies: The college committees like Planning Board, Hostel Committee, etc. too take important decisions. Teachers' unit and Students' Union also play a vital role in policy making and implementation process.

Service Rules, Procedures, Recruitment and Promotion Policies: Service rules and procedures are guided

This is to be mentioned that College functions under the Directorate of Higher Education, Government of Assam and act as per the instructions of the directorate. The principal source of fund for the College is the state government's fee waiver reimbursement and fee collected from the students.

For this purpose, the college appoints a qualified chartered accountant with approval from the Governing Body of the college. For last 5 years, college had regularly conducted internal audits.

7.2 Best Practices

7.2.1 Describe two best practices successfully implemented by the Institution as per NAAC format provided in the Manual

Response:

Best Practice - I

Heritage Conservation- Dewalkhanda Temple, Mazbat.

Heritage Conservation is one of the measures that connects the facts from the past to present. The Dewalkhanda Temple site is an important archaeological site. The people opine that the temple site reflects its ancient history. The relics of the temple show its relation to Ban King. The

relics of the temple are similar to those of the Gupteswar Temple of Shingri, Mahabhairab of Tezpur and Haleswar Temple near Balipara. The temple premise covers nine bighas of land.

There is a pond in the temple premises. Dewalkhanda Shiva Temple is located some 3 km east of Mazbat in Udalguri. The temple houses some fine pieces of relics such as pillar base, lintels, stones and Shivalinga. The objectives:

- 1.To safeguard, restore and enhance heritage site of Dewalkhanda Temple as this represents the beautiful History of Assam.
- 2. To educate, conserve, and inspire best practices in the field of heritage conservation.

Evidence:

Respecting the authenticity of the Dewalkhanda Temple site, a genuine effort has been made to keep the relics well preserved, without any external transformations or any alterations through series of restoration works. Various brain storming sessions were conducted with villagers, civic leaders, social workers and strategies have been formulated to restore this place. Measures like excavations had been done with local community in the vicinity of the temple premises. Some of the relics were discovered after the excavation. Department of History of Mazbat College has been engaged in preserving the relics. Sheds are constructed to restore the relics as found. College community had conducted several awareness programmes, meetings with Government Officials, public representatives to make the campus beautiful. The initiatives of the college has increased the participation of Local People in conservation initiatives. Department of Archaeology, Assam have been approached to further excavate

the site. College community has been trying to educate temple management committee on various conservation measures. Moreover plantation in the premises, cleaning the campus have become regular activity. Recently construction of meeting hall had been completed, guest house construction is under process to make the place tourist frieldly.

The practice:

College community has been constantly monitor the proper conservation of the relics as found in the temple premises. College is focusing on protection and care of tangible artefact as kept in the temple site. Plantation drive by students is also a regular activity in the premises. The college is also helping Temple Management Committee on mobilising public for fund generation etc.

However the challenges to be addressed are:

- 1. The temple preservation and restoration requires appointing specialized conservation architects, which is a challenging task.
- 2. Another major constraint is availability of funds.

The measures are depiction of continuing commitment of the College in heritage conservation as one of the Best Practices.

Best Practice-II

Implementing Green Initiatives

- To implement practices to ensure pollution free environment
- To shift towards renewable energy, like solar plant
- To conserve water and energy in the campus

The Practices:

Mazbat College encourage students and teaching staff to contribute to a green future. The college focuses on promotion of recycling and reusing practices and sustainable environmental management that entails the principle of the 3 "R": "Reduce, Reuse and Recycle". The college performs an energy study on the types of power required, most advantageous tariff and lighting mechanisms, taking into account the electrical needs of the campus. Also the college takes advantage of natural lighting and study light needs in the different areas of the classrooms and work places. We encourage our students and staff to turn off lighting in unoccupied spaces, whether in meeting rooms or in vacant offices or in offices outside working hours and unused electronic equipment, avoiding the "standby" mode. Our efforts are more in the direction to improve the environmental impact and to support mother-nature.

Some details of which are as follows:

- The college has developed beautiful campus with Garden.
- Ponds are constructed in the college campus and the rainwater harvesting facility.
- The college has installed renewable energy plants like solar energy panels. Recently Solar Power Generation Plant has been installed.
- The college has preserved Flora and Fauna on the campus.
- Signboards/posters are displayed in the college campus for encouraging ideas of plastic-free campus, noise pollution, and environmental awareness.
- The college organizes seminars/workshops, quiz etc. on environment-related issues.
- LED bulbs are installed in the college buildings to save electricity.
- For Safety and Security Measurements, the college has fire extinguishers and CCTV system in campus.
- Protected Water Supply measures taken are: In-house water treatment plant and RO drinking water machines.

Evidence of Success:

This best practice has proven to be successful through the following activities:

- 1. Through periodical tree plantations, Flora and Fauna on the campus has enriched, which has turned into eco-friendly campus.
- 2. Out of total required power supply, electrical power consumption will be met through the use of Solar Energy once plant becomes functional.
- 3. Awareness campaign for the plastic-free campus through signboards/display boards.
- 4. Green audit and Energy audit of the campus is done recently.
- 5. For quality management system in water quality, the following are the evidential proofs: Certification for Water quality

Thus, initiative entitled "IMPLEMENTATION OF GREEN INITIATIVES" is practiced in the college in very efficient manner.

Problems Encountered and Resources Required:

While carrying out this practice, following problems are encountered by the college.

- 1. Green Campus initiatives are challenging, so it requires determination and a long-term assurance from all the stakeholders.
- 2. Green Campus initiative is rather expensive practice. It needs an expert advice and investment of resources.

7.3 Institutional Distinctiveness

7.3.1 Portray the performance of the Institution in one area distinctive to its priority and thrust within 1000 words

Response:

The vision of the college is to provide value based quality higher education to ignite students to be honest seekers of knowledge, truth and earnest agents of transformation. The College has provided tremendous thrust and priority to its program of delivery by imparting value based knowledge and enabling students to be socially responsible to transform self and society - an area distinctive to the Vision of the College. Therefore, the focus of the College is to educate, enable and empower young students of different communities of this Assam-Arunachal Pradesh boarder under Bodoland Territorial Region of Assam.

Pursuing its vision integration, in the last five years, the College provided financial assistance to several students with partial fee waivers and also full fee waivers. This assistance was in addition to the support received by reserved category students from state and central Government. The College emphasizes the need to mainstream the marginalized and weaker sections of the society to ensure justice and equity. The motive behind is to steer the education it offers not only towards the realistic goal of employability, but also to build a life of the mind and sensitize and orient its students to the service of the community, in the quest for a better life for society and the world that we inhabit.

Justice and Equity for the people of Mazbat area is thrust of the college for social commitment. The college community is working for the betterment of the people in Tea Garden Areas since Mazbat area is surrounded by several tea estates.

Some of the critical issues needed to be tackled are Witch Hunting, Alcohol Consumption Habits, Domestic Violence, Drop Out students, Health Awareness Camp, Income generating activities for the women of the area.

Witch Hunting is a significant issue to be tackled. Various incidents of Witch Hunting occurred at several places (especially in Bhutiasang and Lamabari Tea Garden) and therefore college conducted several awareness camps with people of Tea Garden areas in association with District Legal Service Authority, Udalguri and Mazbat Mahila Samiti. Initially reluctance from public was seen but after several initiatives incidents have come down drastically.

Another common issue is consumption of local liquor. This social menace also creates lots of problems in society. Even several death occurred due to the consumption of this liquor. Mazbat College women cell and students in association with Mazbat Mahila Samity conducted several awareness activities like street plays, meetings with local people and awareness rally. This resulted in less domestic violence, more number of enrolment in schools.

Domestic Violence is another issue that has ruined so many lives, broken families and spoiled the future of the child. College students were involved in conducting series of activities to aware the people about this evil.

Primary School Drop Out is yet another problem in Garden areas. Mazbat College Women Cell, Alumni Assocation and Mazbat College Students Union conducted meetings with Garden Authority, Parents and Teachers to find out the solution for this. College has donated several playing equipment to the Tea Garden Primary schools to make the school environment kids' friendly.

College being a higher educational institute committed to provide exposure to women of the area in income generating activities. Various programmes were organised to meet this goal. Exhibition cum sell mela one of the activities that offers them a platform to showcase and sell their products. Mazbat College Women Cell in association with Jivika (An income generating programme of Women SHGs) had helped many women SHGs to start income generating activities like Knitting and Cutting units, Looms, Piggery units by conducting various awareness programmes.

Creating Awareness on Healthy Life is another focus of the college. Diseases like Malaria, Typhoid, Dysentery are some of the common diseases usually occur in the Garden areas. College conduct various awareness programmes to create awareness among the people of the Gardens. During Covid-19 period,

College took pro active measures too. Awareness Campaigns were conducted in association with Mazbat mini PHC in different places about covid appropriate behaviours. Moreover, during Covid-19 pandemic period, masks, sanitisers and food articles were distributed.

College had chosen Dewalkhanda Village to promote Organic Cultivation. Students were oriented about the process of paddy cultivation and given hand on experience under the guidance of agricultural experts and department of History..

Some other activities conducted with active participation of students like plantation drive at adopted village, conducting voters awareness Programme to create awareness about electoral process, conservation of relics at Dewalkhanda Temple Campus of Mazbat.

Under its Program of delivery by imparting value based knowledge and enabling students to be socially responsible to transform self and society, the College is committed to supporting extraordinary individual initiatives to enable young, enthusiastic women to realize their dreams and aspirations. Women Cell of the College is led by dynamic and committed female faculty members who are very much proactive for the equal rights of female students of the college. They conduct various activities to empower the female students, they include talk on sexual harassment at work place, menstrual hygiene, free check up camps, career counselling sessions etc. Even counselling sessions are also conducted for the female folk of the campus.

In a nutshell, Mazbat College is a socially responsive higher educational institute in this remote area of Bodoland Territorial Region of Assam. Above mentioned programmes clearly shows our commitment to the society.
