Now the above parties hereby agree to the following:

1. Preamble & background for the MOU:

The first party is engaged/ specialist in the field of Academics.

The second party is engaged/ specialist in the field of Academic.

2. Purpose of the MOU:

Enlist the purpose of MOU in brief:-

The objective is to promote collaboration, provide opportunity for global experience, and to assist advancement of knowledge on the basis of reciprocity, best effort, joint benefit, and frequent interactions. Kanya Mahavidyalaya, Guwahati-21, Assam, India and Mazbat College, Mazbat, Udalguri, Assam 784507.

3. Roles & Responsibilities:

I) First party agrees to carry out the following responsibilities:

- a) To exchange information on educational programmes and education events.
- b) To exchange information on teaching, learning material and other literature relevant to their educational and research activities.
- c) To mutually organize short-term continuing education programmes on topics of mutual interest and to invite each other's faculty to participate therein.
- d) To mutually organize seminars, webinars, conferences, workshops, research publications, edited books on topics of mutual interest and to invite each other's faculty to participate therein.
- e) To mutually suggest and engage in research or training programmes sponsored by funding agencies, and to invite each other's faculty to contribute therein.
- f) To exchange, on a reciprocal basis, students at Undergraduate, Graduate and Research levels for limited periods of time for reason of education or research.
- g) To mutually organize education excursion and cultural events.



4. **Effective Date:**

This MOU will come into effect on the date of signature and will remain in force until either side delivers written notification to the other of its intention to terminate the memorandum, in which case the parties will terminate two months after the receipt of such a notification.

5. **Consideration/ Valuation:**

The parties arrived at consideration based on the valuation and the amount is mutually consideration.

6. **Modification:**

The MOU may be amended by mutual consent through an exchange of correspondence between the two partners and by entering into supplementary MOU.

7. **Applicable Law:**

If any clause of this MOU overrides or is contrary to any other prevailing law which is applicable to the parties for the time being in India, then the existing and relevant Act, Rule or Regulation shall prevail over such clause of this MOU.
